General Instructions:-

1. The cost of Bid document fee and Earnest Money Deposit (EMD) deposit shall be deposited in the form of Banker Cheque/Demand Draft/Deposit at call of any scheduled bank payable at Kaithal in favour of Executive Officer, Municipal Council, Kaithal and their Bid Validity is 60 Days for above mentioned works.
2. Bidders should possess digital signature certificate for participating in online tendering process.
3. Bid Document can be downloaded from the website of Haryana Government www.etenders.hry.nic.in

1. Eligibility Criterion:-

- (A) The contractors enlisted/Registered with Haryana PWD(B&R)/HUDA/CWPD/Haryana Tourism/MES/Railways /HSAMB or any other State/Central Govt./Department of Boards /Corporations upto the estimated value of tender are eligible to submit their tenders. In additions to Enlistment stated above, the contractor has to submit certificate/documents regarding satisfactory completion of 02 work of similar nature.
- (B) As tenders are open tenders, contractors/agencies whosoever are not registered with Municipal Council, Kaithal will have to get registered with Municipal Council, Kaithal before allotment of work.

3. The bid Document can be downloaded online from the portal [https:// etenders.hry.nic.in](https://etenders.hry.nic.in) by the agencies/contractor/L&C (Societies) registered on the portal. The bidder who are submitted online are required to submit attested copies of prequalification and other necessary documents of the above mentioned documents work at municipal Council Kaithal as mentioned above.
4. The detail of the Bid Document cost/EMD is required to be uploaded at the time of online submission. The bidders are therefore required to keep the scanned copies of prequalification and other documents of the above mentioned documents ready. This tender will be rejected if the tenderer does not submit all necessary document information online.
5. The tender shall be submitted online by the tenderer in the following two separate covers i.e. technical and financial cover.
- Technical cover consists of: Fee, Scanned copy of Bid Document cost/EMD and scanned copies of the prequalification documents, technical parameter/technical bid.
 - Financial: Financial cover consists of contract schedule of rates (BOQ) which are to be submitted online by the bidder.

Note:- Physical submission of document – Online Bidders will be required to submit physically the bid document cost/EMD and other document related to prequalification, technical parameter/technical bid etc.

Above envelopes (as applicable) shall be kept in bigger outer envelopes, which shall be sealed and submitted at the office of Municipal Council, Kaithal as per scheduled dates.

Note:- Municipal Council, Kaithal reserves the right to verify the authenticity of the document submitted by the bidder online as well as physically. The price bids are to be submitted mandatory online.

6. Opening of Bid:- At the first instance. The cover of all the Bidders containing the Bid Document cost/EMD shall be opened online as well as physically. If the Bid Document cost/EMD is found proper and in order then the cover containing prequalification,/technical bid shall be opened. The Financial cover shall be opened only of those tenderers who meet the prequalification, technical bid criteria as per these Bid Documents.
7. In case, if bid is submitted by a bidder online and technical bid, Earnest Money Deposit(EMD) or other document as required as per the bid document, are not submitted in physical form then the bid of the bidder would be rejected.
8. In case, if bid opening day of tenders happens to be holiday, the tenders will be opened on the next working day. The time and place of receipt of tenders and other conditions will remain unchanged.
9. The L&C societies shall have to produce an attested copy of the resolution of the cooperative department for submission of online bids in the e-tendering system.
10. The bidder who does not satisfy the qualification criteria in the Bid Documents are liable to be rejected without assigning any reason and no claim whatsoever on this account will be considered.
11. If any tenderer, modifies or withdraws his tender subsequent to submitting it to the Municipal Council Kaithal, he is liable to be blacklisted as well as his earnest money shall be forfeited without prejudice to other rights and remedies available to the M.C.
12. The Bidder whose tender is accepted will be required to execute an agreement in the prescribed form and will be required to furnish 10% of the security fee for the due fulfillment of this contract or alternatively at the discretion of the Engineer-in-charge it will be deducted from the running payments which are to be made on account of work done. (The earnest money will be treated as part of security).
13. The approval of the acceptance of tender will rest with the concerned competent authority which is not binded to accept the lowest tender and reserves the authority to reject or accept any or all of tenders received without assigning any reason.
14. The successful tenderers shall have to sign an affidavit with due effect that he has no relation or connection with firm/contractor, blacklisted by Municipal Council, Kaithal/HUDA/PWD or any other offices.
15. The Earnest Money Deposited (EMD) for the tender will not be returned to the contractor/firms till the acceptance of tender or three months whichever is earlier.
16. Sales/works Tax, Income Tax cess or any other tax applicable will be deducted from the bills of contractor as per the instructions of the Govt.
17. The competent authority reserves right to accept or reject any or all of the tenders without assigning any reasons as per sub rules of MW 4, General Rules and Directions for the guidance of contractors.
18. Conditional tender shall not be accepted.
19. Original Components & other parts will be used UI's/ tested having Traffic Signal material (makes Safetrans/Effitron/Swarco,...(as per DNIT terms)
20. The material having quality control certifications like UL's (USA)/IRC/EN- 12966 (ARAI). Certification like UL's /IRC most recommended /EN-12966 M.O.R.T.H. Certification, Indian Road Congress. NO PLC BASED SYSTEM ALLOWED IN TRAFFIC SIGNALLING SYSTEMS

21. All Traffic light modules having IP-65 Standards Poly Carbonate & with quality tests as per latest NEMA with TUV IRC/ITE standards
22. Copy of quality certifications material with technical document should be attached . No tender accepted without quality certifications.
23. No payments will be released without checking of quality Parameters/Controllers working Specifications
24. The agency has to do the work strictly as per DNIT specification IRC guidelines
25. Firm/Company having 7 years Experience in Traffic Signals Installations, experience Satisfactory certificates of wireless signals attached with technical bid.
26. Copy of Authorization/ M.O.U. for the company (Quality certified) attached with Technical Bid, without Authorizations/ M.O.U. No quality tests documents related technical bid accepted & tender may rejected.
27. Manufacture firm having min. 50 no. satisfactory installations of wireless signals certifications (issued by Executive Officer/Commissioner/gazzeted rank officer submit with bid)
